If you are submitting a grant application on behalf of someone else, please consider the amount of the grant requested, keeping in mind tax implications for the recipient (noted above). You will be notified if a grant is approved or denied. If a grant of \$600 or more is approved, the applicant can decide if they would like the board to contact the recipient regarding the W-9, or if the applicant would like to contact the recipient. A grant can be approved without a W-9 but funds cannot be delivered to a recipient without completion of a W-9 (if over \$599).

5. Eligibility Documentation Provided:

Please allow six (6) weeks for review and determination. An application does not guarantee an award. By submitting an application, the applicant agrees that if additional information is required by the Foundation to aid review, the applicant shall be available for interview by phone or in person.

Honoring the legacy of Heather Frazer Boyum shall be a significant consideration in determining award recipients. Both the Frazer and Boyum families shall be involved in making such determinations. Preference shall be given to applicants residing or operating within the Greater Rochester Area.
